10. **Urban Grass Cutting, North Yorkshire Council –**

- 10.1 To receive a letter from North Yorkshire Council explaining that the council is offering to pay Town and Parish Councils to undertake urban grass cutting on their behalf as in previous years. The rate that they will pay has been raised 3.4% from 2025 to 8.27p per m²
- 10.2 To decide if the parish council wishes to continue urban grass cutting and be reimbursed £133.49 for Cleasby and £127.02 for Stapleton.
