



## **STAPLETON AND CLEASBY PARISH COUNCIL MEETING**

### **1. Apologies**

1.1 Apologies were received from Cllr L Heritage and Cllr C Mitchell

1.2 The reasons for absence were considered and approved.

### **2. Declaration of Interest**

2.1 No declarations of interest were declared.

2.2 There were no applications for dispensation.

### **6. Co-option of a new Councillors**

6.1 A written application from a resident of Stapleton to become a member of Stapleton and Cleasby parish council was received.

6.2 It was agreed to co-opt the resident as a member of the parish council. Councillors welcomed Elaine Leckie, who was in attendance, as a member of the parish council . The declaration of acceptance was signed at the meeting.

## 7. To discuss any matters arising from the minutes:

7.1 **Tree Survey** - A quote to remove the diseased trees highlighted in the Tree Survey report was received.

7.1.2 It was decided to accept the quote from Rennison Tree Specialists and instruct them to carry out the works to remove the 3 dangerous trees.

7.1.3 No further actions required.

7.2 **Dog waste bin, Cleasby** – It was decided to remove the broken dog waste bin as it is located next to a new general waste bin. Clerk to ask for some more dog litter bin stickers from North Yorkshire Council.

7.3 **Grit bin, Cleasby**- It was noted that an email has been received from Ian Beighton, Project Engineer at North Yorkshire Council, saying he would come out to look at the grit bin and see if there are any other suitable locations for it to be moved to.
